

## KENS 5 MI CASA, MY COMMUNITY CONTEST

### OFFICIAL RULES

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**
- 2. Eligibility.** Subject to the additional restrictions below, The KENS 5 *Mi Casa, My Community* Contest (the "Contest") is open to individuals who are legal U.S. residents of Texas. Employees or contractors of KENS-TV, Inc. ("KENS 5" or "Sponsor"), TEGNA Inc., all Promotional Sponsors named at the end of these rules and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with any such employees, contractors or sponsors are not eligible to enter or win. Anyone who has won a KENS-TV contest or sweepstakes within the past 90 days prior to the start date of this contest is also not eligible to enter or win.  
  
**3. How to Enter.** The Contest Entry Period will begin at 8:30 am (CT) September 5, 2017, and will end at 5:30 pm (CT) August 31, 2018. During the Contest Entry Period the Entry Form is available on kens5.com at [www.kens5.com/micasa](http://www.kens5.com/micasa). Complete the required information and follow all instructions. The Entry Form along with any optional, relevant photos or videos must be authentic, original and you must own all rights, including the copyright, in any photos, video or other materials you submit. Sponsor reserves the right to refuse any photograph it determines to be unacceptable or inappropriate. In addition to the Entry Form, you must also write a description (250 words or less) of the need or person(s) or organization in need and why you believe they deserve to win. Only one nomination is permitted per Entry Form.  
  
**Nominator and Nominee.** You must be a legal U.S. citizen who is 18 years of age or older, and residing in the State of Texas and within the KENS 5 viewing area (as defined by Nielsen DMA criteria which includes the Texas counties of Atascosa, Bandera, Bexar, Comal, Guadalupe, Kendall, Medina and Wilson). You may self-nominate or nominate someone else that is in need of help to win the *Mi Casa, My Community* Contest.  
  
Sponsor will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries, or poor quality photos or videos. You must agree to make yourself available when called upon for additional information. All entries become the property of Sponsor and none will be returned. IF YOU DO NOT WISH TO SHARE YOUR INFORMATION, PLEASE DO NOT ENTER THIS CONTEST.
- 4. Winner Selection.** Judging of all eligible entries will begin on September 18, 2017 and run once each calendar month through August 2018. A panel of qualified judges made up of KENS 5 station personnel and Sponsor personnel will judge eligible entries by the following criteria – (1) nominee's need, (2) submitted description/story, and (3) overall expenditure to fulfill. The ratings scale for each criterion will range from one (1) to ten (10), with 10 being the best score. In the event of a tie, the judges will revisit the tied entries and re-judge each using the same criteria. The nominated entries with the highest cumulative score each month will become the twelve (12) winning nominations. Sponsor reserves the right to select fewer than twelve (12) winning nominations if, in its sole discretion, it does not receive a sufficient number of eligible and qualified nominations. The judges' decisions are final and binding in all respects.
- 5. Prizes and Odds.** One (1) prize will be awarded each month for one (1) winning nomination. Sponsor will determine all elements of prizes in its sole discretion. Prizes may not be assigned,

transferred, or changed, except at the sole discretion of Sponsor. The awarding of any prize is contingent upon full compliance with these Official Rules. You agree to be bound by Official Rules and agree that if any nominator or nominee fails to provide proof of identity, refuses to provide required documentation, is found to have violated the Official Rules or otherwise does not meet eligibility criteria, prize will be forfeited and awarded to an alternate winner with the next highest score. KENS 5 will call during regular business hours and will leave no messages. Failure to reach the Winner by phone after three (3) attempts may result in disqualification of winner or forfeiture of prize, and the entry with the next highest number of points will be declared the Winner. Winning nomination may waive right to receive prize(s). Prizes are non-assignable and non-transferable. No substitutions allowed by winner. Prize is not redeemable for cash. Prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. Winner is solely responsible for reporting and payment of any taxes on prizes. To claim the prize Winner will be required to complete an affidavit of eligibility/liability and publicity release which must be returned as directed by Sponsor.
